TERMS OF RENTAL

Maintenance of Equipment. Applicant agrees to keep and maintain all rental equipment in good condition and assumes full responsibility for all equipment and supplies until the rented items are returned.

Lost or Damaged Equipment. Applicant agrees to assume the entire risk of loss to the equipment through use, operation, theft or otherwise. In the event of loss or damage to the equipment, Applicant agrees to pay the full cost of repair or replacement without deduction for depreciation of the equipment. In the event of any loss or damage to the rented equipment, Applicant agrees to pay the rental rate during the period of time the MMVFC is deprived of the equipment and until such time as it is repaired and/or replaced.

Indemnification and Hold Harmless. Applicant agrees to assume full responsibility and liability for the safekeeping and return of all rented equipment. Applicant agrees to indemnify and hold harmless the MMFC and the City of Moab from any and all liability, claims, damages, costs and expenses arising from Applicant's use, misuse and/or possession of the rented equipment.

Returned Equipment. Applicant agrees to return equipment to the MMVFC in as good order and condition as originally issued, reasonable wear and tear expected. Acceptance by the MMVFC of the return of rented equipment does not waive any claims that the MMVFC or the City of Moab may have against the Applicant for patent, latent or hidden damage to the equipment. The MMVFC shall have a reasonable period of time after return of equipment to discover any damages.

Exclusive Possession/Non-Assignability of Lease. Applicant shall not sublease or loan the equipment or assign this Agreement to any other persons, firms, or corporations and the equipment shall at all times remain under the immediate, exclusive control and direction of the Applicant.
